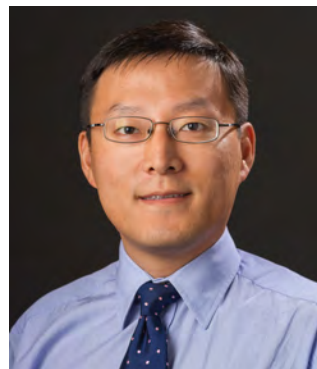

## KEYNOTE SPEAKER



### **Lincoln C. Chen, M.D.**

Dr. Lincoln C. Chen is President of the China Medical Board. Started in 1914, the Board was endowed by John D. Rockefeller as an independent American foundation to advance health in China and Asia by strengthening medical education, research, and policies. Dr. Chen was the Harvard School of Public Health Taro Takemi Professor of International Health, Director of the University-wide Harvard Center for Population and Development Studies, and the founding Director of the Harvard Global Equity Initiative. Earlier, Dr. Chen served as Executive Vice-President of the Rockefeller Foundation, and he represented the Ford Foundation in India and Bangladesh. In addition to serving on many boards, Dr. Chen was the Special Envoy of the WHO Director-General in Human Resources for Health, the Founding Chair of the WHO-based Global Health Workforce Alliance, and a founding member of Advisory Board to the UN Secretary-General of the UN Fund for International Partnerships. Dr. Chen is a member of the National Academy of Sciences' Institute of Medicine, the American Academy of Arts and Sciences, the World Academy of Arts and Sciences, and the Council on Foreign Relations.



### **Paul D. Cleary, Ph.D.**

Dr. Paul D. Cleary is the Anna M.R. Lauder Professor of Public Health in the Department of Health Policy and Management. He served as Dean of the Yale School of Public Health from 2006 to 2017. He holds secondary positions as Professor of Sociology and in the Institute for Social and Institute for Social and Policy Studies. He directs the Yale Center for Interdisciplinary Research on AIDS (CIRA), which provides infrastructure support to almost 50 research and training grants and over 150 affiliated scientists. Dr. Cleary has been a member of the Academy of Medicine (AOM) since 1994. He has also been a member of the Connecticut Academy for Science and Engineering since 2007. In 1996, he was selected as a distinguished fellow of the Association for Health Services Research, and in 2002, received the Distinguished Investigator Award from the Academy for Health Services Research and Health Policy. In 2010, Dr. Cleary was awarded the Picker Award for Excellence in the Advancement of Patient-Centered Care by the Picker Institute. From 2005 to 2016 Dr. Cleary chaired the National Advisory Committee for The Robert Wood Johnson Foundation Investigator Awards in Health Policy Research Program.



### **Michael Grossman, Ph.D.**

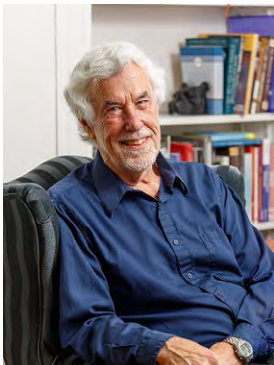
Dr. Michael Grossman has been affiliated with the National Bureau of Economic Research since 1966. Currently, he directs the NBER's Health Economics Program and is Distinguished Professor of Economics at the City University of New York Graduate Center, where he has taught since 1972. He is a member of the Institute of Medicine of the National Academy of Sciences, a past president of the Eastern Economic Association, and the past president of the American Society of Health Economists. His research has focused on economic models of the determinants of health, the economics of substance use and abuse, and the determinants of interest rates on tax-exempt hospital bonds. Dr. Grossman is the inaugural recipient of the Victor R. Fuchs Award for lifetime contributions to the field of health economics, presented by the American Society of Health Economists in 2008.



### **Harlan M Krumholz, M.D.**

Dr. Harlan Krumholz is a cardiologist and health care researcher at Yale University and Yale-New Haven Hospital. He is the Harold H. Hines, Jr. Professor of Medicine and Director of the Yale Center for Outcomes Research and Evaluation (CORE), one of the nation's first and most productive research units dedicated to producing innovations to improve patient outcomes and promote better population health. He is also a Director of the Robert Wood Johnson Foundation Clinical Scholars Program, which prepares talented physicians to become future health care leaders. Dr. Krumholz has been honored by membership in the Institute of Medicine, the Association of American Physicians, and the American Society for Clinical Investigation. He was named a Distinguished Scientist of the American Heart Association. He was elected to the Board of Trustees of the American College of Cardiology and the Board of

Directors of the American Board of Internal Medicine, and was appointed by the U.S. government to the Board of Governors of the Patient-Centered Outcomes Research Institute. He is a 2014 recipient of the Friendship Award from the People's Republic of China in recognition of his collaborative efforts to develop a national cardiovascular research network.



### **T Paul Schultz, Ph.D.**

Dr. T Paul Schultz is Malcolm K. Brachman Professor Emeritus in Economics at Yale University since 1975, Director of Economic Growth Center at Yale University 1983-1996, and previously Professor at the University of Minnesota, Founder and Director of Population Research Program at the Rand Corporation, and economist with the Joint Economic Committee, U.S. Congress, and intern Council of Economic Advisors. President of the European Society for Population Economics, Fellow American Association for Advancement of Science, Member of the Conference on Income and Wealth, NBER and IUSSP, Senior Research Fellow, Institute for Policy Reform, Bureau for Research and Economic Analysis of Development, and Institute for the Study of Labor, and National Associate, National

Academies of Sciences, Engineering and Medicine, and Fellow Econometrics Society. Irene Taeuber Award for Research by the Population Association of America, and member of the Board of Trustees, Economic Research Forum for Arab Countries, Iran and Turkey.



### **Jody L. Sindelar, Ph.D.**

Dr. Jody Sindelar is a Professor of Public Health and Economics at the Yale School of Public Health (YSPH), Department of Health Policy and Management (HPM), and at the Yale University Department of Economics. In addition, she is a Research Associate at the National Bureau Economic Research (NBER), Research Fellow at the IZA Institute of Labor Economics, Associated Faculty at the Institution for Social and Policy Studies (ISPS) at Yale, Bing Visiting faculty at Rand Corporation in Santa Monica, CA and Washington, DC, and has been the President-elect, President, Past President & founding member of the American Society of Health Economists (ASHEcon). Dr. Sindelar is an expert on the economics of substance abuse, including alcoholism, illicit drugs and smoking, as well as obesity. Her studies include lost

productivity, cost-effectiveness of treatments, social costs, and policy. She has published over 100 papers and studies on the impacts of substance abuse on productivity, educational attainment, gender differences, and related policy issues in economics, policy, addiction, health and medical journals. She has served on numerous editorial, review, advisory and other boards and committees, and has presented her research at seminars and conferences both nationally and internationally.





### **Sten H. Vermund, M.D., Ph.D.**

Dr. Sten Vermund is Dean and Anna M.R. Lauder Professor of Public Health; Professor of Epidemiology (Microbial Diseases); Professor of Pediatrics. He is a pediatrician and infectious disease epidemiologist focused on diseases of low and middle income countries. His work on HIV-HPV interactions among women in Bronx methadone programs motivated a change in the 1993 CDC AIDS case surveillance definition and inspired cervical cancer screening programs launched within HIV/AIDS programs around the world. The thrust of his research has focused on health care access, adolescent sexual and reproductive health and rights, and prevention of HIV transmission among general and key populations, including mother-to-child.



### **Gonghuan Yang, M.D.**

Dr. Gonghuan Yang, a Full Professor of public health, a senior epidemiologist on chronic non-communicable diseases and related risk factors, especially focused on tobacco use and environmental pollution. She has worked in project of adult health study in developing countries of World Bank and Tobacco Free Initiative of WHO. She took the deputy Director General of China CDC and Director of Tobacco Control Office during 2005-2011. During the period, she organized the study relationship between the Water Pollution of Huai river and the digestive cancer, which is firstly the positive answer is that water pollution of Huai river is related to the high occurrence of digestive cancer in the areas at that time. She gained 6 Science and Technology Achievement Awards from Ministry of Health, Ministry of Education, Chinese Medical Association and Chinese Preventive Medicine Association. She obtained 2006 the World Health Organization Award of outstanding contribution to tobacco control.



### **David Youtz**

David Youtz became the executive director of the Yale-China Association in June 2015, continuing a career of more than 25 years in American and Asian not-for-profit organizations. David previously served as senior consultant at the National Committee on U.S.-China Relations (of which he is also a member), where he led strategic planning and the launch of a new U.S.-China energy initiative. From 2007 to 2011, he was the CEO of the Hong Kong-based NGO, Mother's Choice, and for the previous six years, David headed Morgan Stanley's Asia Desk at its New York headquarters. He has held leadership and programming positions at The Asia Society, the New York-based think tank EastWest Institute, and World Monuments Fund, and was president for seven years of the nationwide adoption advocacy organization, Families with Children from China of Greater New York. Earlier in his career he was Yale-China's Hong Kong Director and Vice President (1991-1997), where he supervised the organization's education and teacher-training programs in China and Hong Kong, and managed projects in American studies, health, environmental studies, and the arts. In 2008, he received a Chua Scholarship for Non-Profit Leadership from the Harvard Business School Association of Hong Kong, and was awarded a New York City Council Outstanding Citizen Citation in 2005.

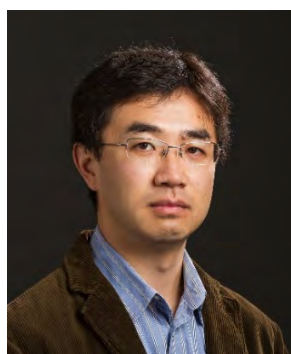
### **Michelle L. Bell, Ph.D.**

Dr. Michelle Bell is Mary E. Pinchot Professor at the Yale University School of Forestry and Environmental Studies, with secondary appointments at the Yale School of Public Health, Environmental Health Sciences Division and the Yale School of Engineering and Applied Science, Environmental Engineering Program. She is the recipient of the Prince Albert II de Monaco/Institut Pasteur Award, Rosenblith New Investigator Award, and the NIH Outstanding New Environmental Scientist (ONES) Award. Dr. Bell's research investigates how human health is affected by atmospheric systems, including air pollution and weather. Much of this work is based in epidemiology, biostatistics, and environmental engineering. The research is designed to be policy-relevant and contribute to well-informed decision-making to better protect human health.



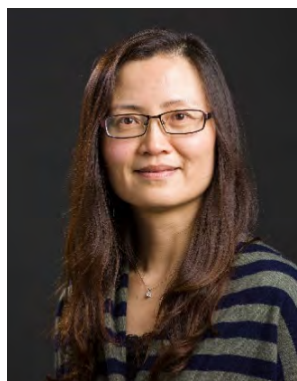
### **Professor Geoffrey T. Fong, Ph.D., FRSC, FCAHS**

Dr. Geoffrey T. Fong, Ph.D., FRSC, FCAHS, is Professor of Psychology and Public Health and Health Systems at the University of Waterloo, and Senior Investigator at the Ontario Institute for Cancer Research. Dr. Fong is the Founder and Chief Principal Investigator of the International Tobacco Control Policy Evaluation (ITC) Project, a research consortium of over 150 researchers across 29 countries, covering over two-thirds of the world's tobacco users, including China, where the ITC Project, in collaboration with the Tobacco Control Office of the China CDC (Dr. Jiang Yuan, lead investigator), since 2006. The ITC Project is the world's largest tobacco research program, focusing its efforts on evaluating the effectiveness of tobacco control policies of the WHO Framework Convention on Tobacco Control (FCTC). Dr. Fong has published over 300 journal articles and was one of the Scientific Editors of the 2017 WHO/US National Cancer Institute Monograph, *The Economics of Tobacco and Tobacco Control*. He has also served as an expert consultant for many countries including Canada, Brazil, the United Kingdom, and two countries—Australia and Uruguay—whose tobacco control policies have been challenged by the tobacco industry via trade treaties. Dr. Fong was also a member of the independent expert group formed by the FCTC Conference of the Parties to assess the impact of the FCTC over its first decade. Dr. Fong has received a WHO World No Tobacco Day Award, a Luther L. Terry Award from the American Cancer Society for Outstanding Research Contribution, and the 2017 Policy Impact Award from the American Association for Public Opinion Research. He is a fellow of the Royal Society of Canada and of the Canadian Academy of Health Sciences.



### **Shuangge Steven Ma, Ph.D.**

Dr. Shuangge Ma is a Professor of Biostatistics at Yale School of Public Health. Dr. Ma received his Ph.D. degree in statistics at University of Wisconsin in 2004. Prior to arriving at Yale, Dr. Ma was a Senior Fellow in Collaborative Health Studies Coordinating Center (CHSCC) and Department of Biostatistics at University of Washington. He has been involved in developing novel statistical and bioinformatics methodologies for analysis of cancer (NHL, breast cancer, melanoma, lung cancer), mental disorders, and cardiovascular diseases. He has also been involved in health economics research, with special interest in health insurance in developing countries.



### **Yawei Zhang, Ph.D. M.D.**

Dr. Yawei Zhang is Section Chief Surgical Outcomes and Epidemiology, Yale Department of Surgery; Associate Professor, Yale School of Public Health. Dr. Zhang's research focuses on cancer prevention and prognosis, early life exposures, and surgical outcomes. In particular, she has been pioneering the causes of increasing trends of thyroid cancer observed worldwide. Currently, she is leading a large project developing novel approaches of monitoring and controlling major cancer risk factors in China. Dr. Zhang's birth cohort studies in Lanzhou and Taiyuan, China focus on investigating a wide range of environmental and lifestyle factors, genetic and epigenetic changes, gene-gene and gene-environment interactions, and risk of adverse birth outcomes and maternal complications. Dr. Zhang is bringing in her expertise to surgical outcome research in the Department of Surgery to

develop a world-class frontier surgical outcome research program through cutting-edge evidence-based surgical outcome research projects, surgical outcome educational program, and international collaborations.



### **Hongyu Zhao, Ph.D.**

Dr. Hongyu Zhao is the Ira V. Hiscock Professor of Biostatistics and Professor of Statistics and Genetics, Chair of the Biostatistics Department and the Co-Director of Graduate Studies of the Inter-Departmental Program in Computational Biology and Bioinformatics at Yale University. His research interests are the applications of statistical methods in molecular biology, genetics, drug developments, and personalized medicine. Some of his recent projects include large scale genome wide studies to identify genetic variants underlying complex diseases (schizophrenia, bipolar, autism, and substance sbuse), biological network modeling and analysis, disease biomarker identification, genome annotations, microbiome analysis and systems biology study of herbal medicine. He was the recipient of the Mortimer Spiegelman Award for a top statistician in health statistics under the age of 40 awarded by

the American Public Health Association. His research has also been recognized by the Evelyn Fix Memorial Medal and Citation by UC Berkeley, a Basil O'Connor Starter Scholar Award by the March of Dimes Foundation, election to the fellowship of the American Association for the Advancement of Science, the American Statistical Association and the Institute of Mathematical Statistics.



### **Gongwei Zhou, Ph.D.**

Zhou Gongwei, Ph.D of Economics, Deputy Director of Center for Health Statistics and Information of National Health Commission of P.R.China. He has long been engaged in the research of China's population development strategy, health informatization and health care. Prior to his work at CHSI, he worked at the Department of Planning and Information, Department of Family Planning and Development of the National Health and Family Planning Commission of the P.R.China. He is also the Deputy Secretary General of China Health Information and Big Data Association.
